1. We are pleased to offer food truck vendors a rate of \$350 & booths at \$250 to participate in this event.
You are required to have your own generator.
2. We provide food truck space. You are responsible for handling all monies and tax at your truck.
We do not take a percentage of your sales.
3. Food Truck Vendors must provide a **menu, signage and enough food** to last the length of the event. In the event that you sell out you **MAY NOT** vacate early. It is your responsibility to market yourself accordingly.
4. Truck space fees are non-refundable and non-transferable. No shows forfeit all fees paid.
Event will take place **RAIN OR SHINE** Bear River Casino Resort reserves the right to remove any exhibitor for any cause and at any time. No refunds will be issued!
5. Event is **Taco Fest**. A minimum of 3 menu items are required. **FOR EXAMPLE: TACO, BURRITO, SWEET CORN**
You must provide: BEAR RIVER CASINO RESORT WITH VALID BUSINESS OR FOOD TRUCK EQUIVALENT LICENSE
6. Setup starts at 7:00AM. All trucks must be set up and ready by 9:30am pre-event inspection time.
Trucks may vacate the premises at 7:00PM and no later than 8PM.
(NOTE) CAN MAKE ARRANGEMENT TO SET UP THE DAY BEFORE
7. Advertising/marketing of event will be handled by both parties including press releases, newspaper listings, FB & IG, direct mail and signage in the local community. We expect your business to advertise this event immediately upon executed contract, including sharing our website bearrivercasino.com and our FB & Instagram page at BearRiverCasinoResort

Both parties agree to continue to advertise up until the day of event.
